SECTION 2. HAZARD IDENTIFICATION

The products not classified as hazardous under CLP regulations.

METHOD OF USE; Apply compound directly to the spillage and allow to absorb for up to 5 mins, depending on viscosity of the material to be contained. Once absorbed, clear away using broom/scoop/shovel as appropriate.

SECTION 3. COMPOSITION/INFORMATION ON INGREDIENTS

Sawdust (Supplier FSC No. NC-COC-026801) 85% Water 5% added (5% within natural moisture of sawdust) Disinfectant 50 CAS 68424-85-1 <0.1% Methylene blue CAS 61-73-4 <0.0001%

SECTION 4. FIRST AID MEASURES

Skin contact – Wash skin with water

Eye contact – Irrigate eye thoroughly with clean water or eye wash solution.

Seek medical advice

Ingestion – Wash out mouth with water, do not induce vomiting. Seek medical advice.

SECTION 6. ACCIDENTAL RELEASE MEASURES

Sweep up and place into suitable container, then dispose of in normal collection system. As per Section 13. Product can be composted depending on material absorbed during usage.

SECTION 7. HANDLING AND STORAGE

Handling – Wear appropriate protective clothing; avoid contact with skin and eyes.

Storage – Store the bags of compound laid flat in a cool location, turn bags over 2-3 times prior to use in order to remix ingredients.

SECTION 8. EXPOSURE CONTROL/PERSONNEL PROTECTION

No exposure limits have been established for substances present in these products.

Personnel Protection

Hand Protection – The wearing of nitrile gloves as a minimum
Eye Protection – The use of safety spectacles/goggles

Respiratory Protection – None required, but FFP3 face mask recommended
